WHEREAS, the Parties desire to enter into an agreement to Collaborate and Partner to Promote Science, Technology & Innovation for Societal Welfare; and

WHEREAS, the Parties desire to memorialize certain terms and conditions of their anticipated endeavor;

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

1. **Purpose and Scope.** The Parties intend for this MOU to provide the foundation and structure for any and all possibly anticipated binding agreements related to:

- (i) Inculcating scientific temper across civil society through science communication.
- (ii) Facilitating technology dissemination through Academia-Farm-Industry interface, with a focus on rural areas.
- (iii) Fostering innovations and entrepreneurship for societal benefits.
- (iv) Organizing conferences & outreach programmes.
- (v) Capacity building in frontier areas of Science & Technology.
- (vi) Any other aspects with mutual consent.

2. **Objectives.** The Parties agree as follows:

The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfillment of the purpose of the MOU.
