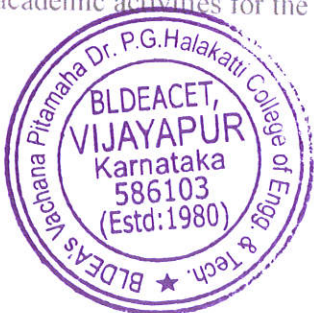

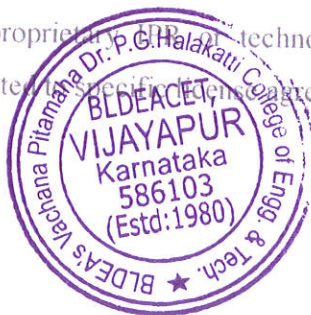
1. INTENT OF MOU



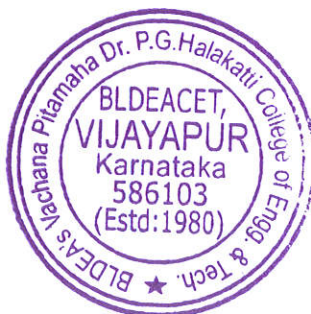
