

MEMORANDUM OF UNDERSTANDING BETWEEN

1. NATURE OF RELATIONSHIP

- The MOU may be amended by mutual consent through an exchange of correspondence between the parties.

2. MUTUAL OBLIGATION

- This obligation shall not be exclusive to both parties and shall not disallow each party from having similar collaboration with others. Except as expressly stated in this MOU, there shall be no obligation on any party to compensate the other in any manner or to make any claim.
- Each party shall meet the expenses between them as mutually agreed.
- Each party shall respect the others intellectual property (IP) and shall not use any trade name, trade mark, symbol or designation belonging to other, without prior written approval. No party shall hold out as an agent or representative of the other or create any liability for the other. The parties shall indemnify the other for breach of this clause.
- Both parties shall maintain confidentiality about any information, project material, plans, discussions, strategies or any other material which shall be deemed to be confidential and marked accordingly. Any information or project material or the like in the public domain shall not be part of this commitment. BLDEACET and EIT are jointly bound by the general rules and
