MEMORANDUM OF UNDERSTANDING

BETWEEN IEEE BENGALURU SECTION AND V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY

It is mutually agreed to conduct IEEE Bangalore-Humanitarian Technology Conference (IB-HTC) at V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY, Vijayapur, during 3rd September 2020 to 5th September 2020 together and following are mutually agreed terms and action points:

- An organizing committee shall be formed and committee shall consist of the representatives from IEEE Bengaluru Section and V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY, Vijayapur.
- All Technical Reviews of the papers and their possible publication in IEEE XPLORE for the Conference shall be undertaken by IEEE Bengaluru Section at their own expense.
- V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY, Vijayapurwill
 provide working capital Rs.8.00 Lakhs to conduct the conference.
- IEEE shall proactively support the conference by way of sponsorship, guest faculty, participants and all other help and guidance to make the conference successful.
- 5. All expenses shall be met from the revenue generated from the Conference and any surplus or deficit will be shared equally. However, the share of V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY, Vijayapur for surplus under any circumstances shall not exceed Rs 8.00 Lakhs i.e. equal to the contribution.
- The working committee would target to Rs.24.00 Lakhs from the Conference and Conference
 expenses shall be budgeted at Rs.16.00 Lakhs. The conference is likely to be self-sustaining.

Conference accounts to be finalized after audit of the accounts and surplus/deficit shall be drawn according to the generally accepted principles of accounting. The whole process of finalization of Accounts & Audit shall be completed within four (04) months from the end of the conference. In case of delay in finalization of Accounts & Audit due to circumstances beyond the control of the organizing committee the surplus (upto Rs.8.00 lakhs) if any arrived based on tentative workingby the committee shall be remitted to V.P. DR. P.G. HALAKATTI COLLEGE OF ENGINEERING & TECHNOLOGY, Vijayapur
